

INSTALLATION STEPS

Read instructions carefully - Installation procedure varies with exhaust system.

- 1) Remove inboard and lower energy absorber (E/A) unit mounting bolts from both sides of frame. Remove the upper outboard bolt that attaches the exhaust hanger bracket to end of the frame on driver's and passenger side.
- 2) Position the hitch on the vehicle, and loosely install the 5/16" bolts provided. Use the hitch side arms as a template to drill four holes in the frame. (NOTE: The side arms must sit flat against the vehicle frame. Chisel or drill out rivets holding heat shelld under side arms if required. Also bend heat shield as needed.) (NOTE: Driver's side exhaust hanger bracket must be reattached through the opening in the hitch plate before reattaching shoulder bolt.) This will require washers to be used as spacers between the bracket and vehicle.
- 3) Lower side arms and insert the 3/8 U-bolts through the frame as shown. Raise side arms into position and install the 3/8 conical washers and nuts on the U-bolts.
- 4) Use three 3/8" flat washers provided to shim space between exhaust bracket and the upper outboard attachment for e/a unit on driver's and passenger side. Use existing fasteners to reattach exhaust hanger bracket. Deformation of sheet metal flanges on E/A mounting surfaces is permissible when fasteners are tightened.
- 5) Use hanger plate and 5/16 fasteners to lower exhaust on passenger side if necessary for hitch clearance or bend exhaust hangers as needed for clearance.
- 6) TORQUE SPECS: 5/16" fasteners to 24 ft-lbs / 3/8" fasteners to 45 ft-lbs.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
