# INSTALLATION INSTRUCTIONS FOR NP92-88/ Oe32-88/ SL62-88/ SP82-88/ TR42-88/ TRS42-88

Thank you for purchasing one of our fine quality products. Your seat cover is engineered from high quality materials and designed with precision to give you a long-lasting, well-adjusted fit.

# A. CUSHION COVERS

- 1. Center cover on seat
- 2. Tuck straps through crevice
- 3. Bring front and side stretch material down
- 4. Pass back strap under seat and buckle to front 5. pass side straps under seat and buckle across
  - 6. Adjust straps and buckles to equalize tension

# **B. BACKREST COVER 40 SECTION**

- 1. Remove headrest (see note)
- 2. Open side and bottom velcro on cover
- 3. Unlatch backrest, slip cover over backrest.
- 4. Pass bottom cover through crevice and place backrest in fold flat position
- 5. Close side velcro and pull bottom cover through crevice and velcro at back
- its position 7. With backrest in up position, smooth cover from top to

6. Apply opposite side Velcro on backrest carpeting to hold

# C. BACKREST COVER 60 SECTION

- 4. Ensure cover is installed under seat belt
- 5. Pass bottom cover through crevice and place backrest in fold flat position


